On July 13, 2005, the reporting person was awarded a contingent, performance based grant for an opportunity to earn 3,338 restricted shares. This opportunity was subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon (1) the issuer's performance within the peer groups, the reporting person could earn some, all or none of the shares. The issuer's actual performance resulted in 1,936 restricted shares being granted, which vest as follows: 645 on March 19, 2007, 645 on January 1, 2008 and 646 on January 1, 2009.

On July 13, 2005, the reporting person was awarded a contingent, performance based grant of 5,944 stock options, which were subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon the issuer's performance within the (2) peer groups, the reporting person could earn some, all or none of the options. The issuer's actual performance resulted in options to purchase 3,448 shares being earned, which vest as follows: 1,149 on March 19, 2007, 1,149 on January 1, 2008 and 1,150 on January 1, 2009.
