*On December 21, 2010, in accordance with Italian law, the requisite Italian Internal Dealing forms were filed with Borsa and CONSOB to disclose the transactions described below.*

1. On December 17, 2010, Delfin S.a.r.l. sold to Enrico Cavatorta of Luxottica Group S.p.A. (the Company), pursuant to grants made to him under the Delfin plan, 100,000 ordinary shares of the stock of the Company at a strike price of Euro 13.67 per share, for an aggregate purchase price of Euro 1,367,000.

On December 17, 2010, Mr. Cavatorta sold the following shares on the Milan Stock Exchange's Mercato Telematico Azionario:

- 100,000 ordinary shares of the Company, with an average price per share of Euro 21.934.

2. On December 17, 2010, Delfin S.a.r.l. sold to Roberto Chemello of the Company, pursuant to grants made to him under the Delfin plan, 200,000 ordinary shares of the stock of the Company at a strike price of Euro 13.67 per share, for an aggregate purchase price of Euro 2,734,000.

On December 17 and 20, 2010, respectively, Mr. Chemello sold the following shares on the Milan Stock Exchange's Mercato Telematico Azionario:

- 40,000 ordinary shares of the Company, with an average price per share of Euro 21.997; and
- 160,000 ordinary shares of the Company, with an average price per share of Euro 22.32.

3. On December 20, 2010, Delfin S.a.r.l. sold to Valerio Giacobbi of the Company, pursuant to grants made to him under the Delfin plan, 50,000 ordinary shares of the stock of the Company at a strike price of Euro 13.67 per share, for an aggregate purchase price of Euro 683,500.

On December 20, 2010, Mr. Giacobbi sold the following shares on the Milan Stock Exchange's Mercato Telematico Azionario:

- 50,000 ordinary shares of the Company, with an average price per share of Euro 22.513.

The Delfin plan was established in 2004. At that time, the Company's Chairman and majority shareholder, Mr. Leonardo Del Vecchio, allocated 9.6 million shares held through La Leonardo Finanziaria S.r.l. (subsequently merged into Delfin S.a.r.l.), a holding company of the Del Vecchio family, to a stock option plan for top management of the Company at an exercise price of Euro 13.67 per share. The stock options to be issued under the stock option plan vested upon meeting certain economic objectives in June 2006.
