- (1) The total beneficial ownership includes 73,4311 shares at \$47.4600 per share acquired under the HP Share Ownership Plan ("SOP") on 10/30/09 and 8,2943 shares at \$47.7616 per share received through dividends paid on 10/07/09 with respect to shares held under the SOP. These shares were held indirectly under HP's 401(k) Plan as of 11/30/09. Fidelity Investments Institutional Services Company, Inc.
- (2) accounts for holdings in the stock fund in units, which are comprised of stock and cash reserves. The shares reported represent an approximate value based upon the fund balance and market value of HP's common stock.
- (3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

The 49.3299 dividend equivalent rights being reported reflect 49.3299 dividend equivalent rights at \$45.96 per RSU credited to the reporting person's account on 10/07/09.
