CIBC Trust Company (Bahamas) Limited, solely in its capacity as trustee of the Reporting Person, has previously executed a joinder to, and thereby has become subject to the provisions of, the Amended and Restated Foreign Global Hyatt Agreement. Accordingly, immediately following the transfer, the shares remain shares of Class B Common Stock.
