(1) On July 13, 2018, FDEF split its common shares 2-for-1. As a result, the 3,671,130 common shares reported on Mr. Reineke's Form 4 filed on July 16, 2018, were split into 7,342,260 common shares. The Form 4 filed by Mr. Reineke on July 18, 2018, reporting shares he acquired should have reflected ownership of 7,438,260 common shares. The additional common shares that resulted from the stock split were omitted from four Forms 4 filed by Mr. Reineke after the filing of the July 18, 2018, Form 4.
