In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) The Reporting Person is an existing trust. On December 15, 2010, for administrative convenience, a trust(s) that was recently formed for the purpose of receiving shares of Class B Common Stock allocated or distributed to newly formed trusts in August 2010 by the co-trustees of a Pritzker Family U.S. Situs Trust was merged into the Reporting Person, and the Reporting Person now holds those shares of Class B Common Stock. The trustee and beneficiary of the Reporting Person are the same as those of such trust(s) that was merged into the Reporting Person.
- (3) No consideration was paid in connection with such merger, which constitutes a "permitted transfer" as defined in the Issuer's Amended and Restated Certificate of Incorporation. Lewis M. Linn, solely in his capacity as trustee of the Reporting Person, has executed a joinder to and become subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following such merger, the shares remained shares of Class B Common Stock.
