- (1) The dispositions reported in this Form 4 were in connection with the merger of the issuer with Admiral Byrd Acquisition Sub, Inc., a wholly-owned subsidiary of AVX Corporation, pursuant to that certain Agreement and Plan of Merger, dated as of June 15, 2007, by and among the issuer, AVX Corporation and Admiral Byrd Acquisition Sub, Inc. (the "Merger"), in exchange for the right to receive a cash payment equal to \$24.75 per share.
- (2) These options, which became fully vested on April 11, 2004 were converted in connection with the Merger in exchange for the right to receive a cash payment of \$21,000, representing the right to receive \$24.75 in cash less the applicable exercise price with respect to each share of common stock underlying such option.
- (3) These options, which became fully vested on February 5, 2006 were converted in connection with the Merger in exchange for the right to receive a cash payment of \$634,400, representing the right to receive \$24.75 in cash less the applicable exercise price with respect to each share of common stock underlying such option.
