Unilever NV announces that on 29 March 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 21.605 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 76,131 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 56,858,833 Unilever NV ordinary shares in treasury, and has 1,657,868,867 Unilever NV ordinary shares in issue (excluding treasury shares).
