By letter dated June 1, 2006, the Company reported that a holder of Company s Convertible Notes exercised their conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 44,310 and accordingly, a capital increase of 81, 302 ordinary shares face value pesos 1 each has been made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 424,423,491 to 424,504,793. The amount of registered Convertible Notes is US\$ 27,979,909.
