**Item 4. Ownership.**

(a) Amount beneficially owned:

As part of its initial public offering, the Issuer issued units (the Units ) consisting of shares of Common Stock and warrants (the Warrants ). Each Unit consists of one share of Common Stock and one Warrant, and each Warrant entitles the holder to purchase one share of Common Stock at a price of \$6.00.

QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ) and for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ). As a result of the acquisition of Units, the Fund beneficially owns 485,986 shares of Common Stock and the Separate Account holds 64,014 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by the Fund and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 550,000 shares of Common Stock, consisting of the shares owned by the Fund and the shares held in the Separate Account.

The Fund and the Separate Account own Warrants that are not exercisable until the later of the Issuer s completion of a business combination and June 7, 2008. As of the date of this filing, there has been no report of the completion of a business combination.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Fund, may be deemed to beneficially own the same number of shares of Common Stock reported by the Fund.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the shares of Common Stock owned by the Fund and the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by the Fund, except to the extent of its pecuniary interest therein.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 9,375,000 shares of Common Stock outstanding, which is the total number of shares issued and outstanding as reported in the Issuer s prospectus filed with the Securities and Exchange Commission on June 8, 2007.
