EXPLANATORY NOTE: This Amendment No. 19 to Schedule 13D (Amendment No. 19) relates to the Class A Common Stock, \$0.01 par value per share, of Hyatt Hotels Corporation, a Delaware corporation (the Issuer), which has its principal executive office at 150 North Riverside Plaza, Chicago, Illinois 60606. This Amendment No. 19 amends and supplements, as set forth below, the Schedule 13D filed by the Reporting Persons with respect to the Issuer on August 26, 2010 (the Original Schedule 13D), as amended and supplemented by Amendment No. 1 to Schedule 13D filed by the Reporting Persons on September 9, 2010 (Amendment No. 1), Amendment No. 2 to Schedule 13D filed by the Reporting Persons on May 18, 2011 (Amendment No. 2), Amendment No. 3 to Schedule 13D filed by the Reporting Persons on November 29, 2011 (Amendment No. 3), Amendment No. 4 to Schedule 13D filed by the Reporting Persons on January 4, 2012 (Amendment No. 4), Amendment No. 5 to Schedule 13D filed by the Reporting Persons on August 22, 2012 (Amendment No. 5), Amendment No. 6 to Schedule 13D filed by the Reporting Persons on December 4, 2012 (Amendment No. 6), Amendment No. 7 to Schedule 13D filed by the Reporting Persons on December 18, 2012 (Amendment No. 7), Amendment No. 8 to Schedule 13D filed by the Reporting Persons on May 17, 2013 (Amendment No. 8), Amendment No. 9 to Schedule 13D filed by the Reporting Persons on June 6, 2013 (Amendment No. 9), Amendment No. 10 to Schedule 13D filed by the Reporting Persons on June 21, 2013 (Amendment No. 10), Amendment No. 11 to Schedule 13D filed by the Reporting Persons on September 6, 2013 (Amendment No. 11), Amendment No. 12 to Schedule 13D filed by the Reporting Persons on November 6, 2013 (Amendment No. 12), Amendment No. 13 to Schedule 13D filed by the Reporting Persons on March 4, 2015 (Amendment No. 13), Amendment No. 14 to Schedule 13D filed by the Reporting Persons on August 31, 2016 (Amendment No. 14), Amendment No. 15 to Schedule 13D filed by the Reporting Persons on December 9, 2016 (Amendment No. 15), Amendment No. 16 to Schedule 13D filed by the Reporting Persons on August 16, 2017 (Amendment No. 16), Amendment No. 17 to Schedule 13D filed by the Reporting Persons on September 14, 2017 (Amendment No. 17) and Amendment No. 18 to Schedule 13D filed by the Reporting Persons on November 21, 2017 (Amendment No. 18). The Original Schedule 13D, as amended and supplemented by Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5, Amendment No. 6, Amendment No. 7, Amendment No. 8, Amendment No. 9, Amendment No. 10, Amendment No. 11, Amendment No. 12, Amendment No. 13, Amendment No. 14, Amendment No. 15, Amendment No. 16, Amendment No. 17 and Amendment No. 18, is referred to as the Schedule 13D. All capitalized terms not otherwise defined herein have the meanings ascribed to them in the Schedule 13D. The Schedule 13D is amended and supplemented by adding the information contained herein. Only those items amended are reported herein.

#### **Item 4. Purpose of Transaction**

Item 4 of the Schedule 13D is amended and supplemented as follows:

On November 21, 2017, Horton Trust Company, LLC, as trustee of P.G. Penny Trust, sold an aggregate of 600,000 shares of Class B Common Stock in a block trade with a broker-dealer at a price of \$70.00 per share, for an aggregate price of \$42,000,000

(the November 2017 Sale ). The November 2017 sale settled on November 27, 2017. In accordance with the Issuer's Amended and Restated Certificate of Incorporation, the shares of Class B Common Stock sold pursuant to the November 2017 Sale automatically converted into shares of Class A Common Stock immediately upon the November 2017 Sale.

#### **Item 5. Interest in Securities of the Issuer**

Item 5 of the Schedule 13D is amended and supplemented as follows:

(a)-(b) As of the date hereof, the Reporting Persons may be deemed to be the beneficial owners of 14,650 shares of Class A Common Stock and 7,215,797 shares of Class A Common Stock issuable upon conversion of 7,215,797 shares of Class B Common Stock beneficially owned by the Reporting Persons. Based on the number of shares of Class B Common Stock outstanding as of November 20, 2017, as reported in the Issuer's Registration Statement on Form S-3, filed November 24, 2017, as adjusted to account for (i) the conversion of an aggregate of 822,085 shares of Class B Common Stock into 822,085 shares of Class A Common Stock in connection with sales by a Separately Filing Group Member on November 17-21, 2017 and (ii) the conversion of an aggregate of 600,000 shares of Class B Common Stock into 600,000 shares of Class A Common Stock in connection with the sale by the Reporting Persons that settled on November 27, 2017, the number of shares of Class B Common Stock beneficially owned by the Reporting Persons represents 10.2% of the total number of shares of Class B Common Stock outstanding. Based on the number of shares of Common Stock outstanding as of November 20, 2017, as adjusted, the number of shares of Common Stock beneficially owned by the Reporting Persons represents 6.1% of the total number of shares of Common Stock outstanding and 9.5% of the total voting power of the shares of Common Stock outstanding, voting as a single class, assuming that no outstanding shares of Class B Common Stock have been converted into shares of Class A Common Stock.

Schedule A attached to this Amendment No. 19 amends and restates, in its entirety, Schedule A attached to the Schedule 13D. Schedule A attached to this Amendment No. 19 sets forth, as of the date hereof, the number of shares and percentage of the Class A Common Stock outstanding, the number of shares and percentage of the Class B Common Stock outstanding, the percentage of the total number of shares of Common Stock outstanding, and the percentage of the total voting power of the shares of Common Stock outstanding, voting together as a single class, represented by the shares beneficially owned by each Reporting Person.

P19M2 Investors II, L.L.C. is a manager-managed limited liability company formed for the purpose of acquiring shares of the Issuer's Common Stock. It directly holds 273,776 shares of Class B Common Stock and has no voting or dispositive power with regard to the shares. P19M2 Investors II, L.L.C. is managed by Horton Trust Company LLC and is wholly owned by one or more of the trusts listed on Appendix A-1.

Based solely on the information contained in the Form 4 filings filed on November 13, 2017 and November 15, 2017 by a Separately Filing Group Member, such Separately Filing Group Member sold an aggregate of 111,003 shares of Class A Common Stock and 218,897 shares of Class B Common Stock.

Based solely on the information contained in the Form 4 filings filed on November 17, 2017, November 21, 2017 and November 22, 2017 by a Separately Filing Group Member, such Separately Filing Group Member sold an aggregate of 1,230,094 shares of Class B Common Stock.

Based solely on the information contained in the Schedule 13Ds, as amended, filed by the Separately Filing Group Members, as of the date hereof, the Pritzker Family Group in the aggregate may be deemed to be the beneficial owners of 36,544 shares of currently issued Class A Common Stock and 68,483,442 shares of Class A Common Stock issuable upon conversion of 68,483,442 shares of Class B Common Stock beneficially owned by the Pritzker Family Group. The number of shares of Class A Common Stock beneficially owned by the Pritzker Family Group and currently issued represents less than 0.1% of the total number of shares of Class A Common Stock outstanding, assuming that no outstanding shares of Class B Common Stock have been converted into shares of Class A Common Stock. The number of shares of Class B Common Stock beneficially owned by the Pritzker Family Group represents 96.8% of the total number of shares of Class B Common Stock outstanding. The number of shares of Common Stock beneficially owned by the Pritzker Family Group represents 57.6% of the total number of shares of Common Stock outstanding and 90.6% of the total voting power of the shares of Common Stock outstanding, voting together as a single class, assuming that no outstanding shares of Class B Common Stock have been converted into shares of Class A Common Stock.

Schedule B attached to this Amendment No. 19 amends and restates, in its entirety, Schedule B attached to the Schedule 13D. Schedule B attached to this Amendment No. 19 sets forth, as of the date hereof, the number of shares and percentage of the Class A Common Stock outstanding, the number of shares and percentage of the Class B Common Stock outstanding, the percentage of the total number of shares of Common Stock outstanding, and the percentage of the total voting power of the shares of Common Stock outstanding, voting together as a single class, represented by the shares beneficially owned by the Reporting Persons and each Separately Filing Group Member. All information with regard to the Separately Filing Group Members is based solely on the information contained in the Schedule 13Ds filed by the Separately Filing Group Members.
