Hi everyone

The planning work for our integration with US Airways continues, so I'd like to provide you a quick update on a few things.

First, back on May 10 Judge Sean Lane, the judge presiding over American's bankruptcy proceedings, entered an order approving the merger. American's creditors, US Airways' shareholders and regulators must still approve the merger, but Judge Lane's ruling is one more step forward for our combination.

While we work towards a closing date in the third quarter of this year, planning work continues as teams from both American's Flight Service and US Airways InFlight departments have been meeting for the past few weeks in DFW and Tempe. The teams have been busy comparing policies, procedures, delivery methods, and technology to determine where we have similarities and where we have gaps. Once the work of identifying gaps is complete, the groups will draft preliminary recommendations on how to close those gaps and present them to a committee comprised of representatives from both American and US Airways. It will likely take one to two years after closing before we begin operating as a single carrier, but as you can see work has already begun to make that transition as smooth as possible.
