### **Item 2.02** Results of Operations and Financial Condition.

On August 9, 2016, Marchex, Inc. (<u>Marchex</u>) is issuing a press release and holding a conference call regarding its financial results for the quarter ended June 30, 2016 (the <u>Press Release</u>). The full text of the Press Release is furnished as Exhibit 99.1 to this Current Report on Form 8-K.

The information in this Item 2.02 (including Exhibit 99.1) is being furnished and shall not be deemed filed for the purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the <u>Exchange Act</u>), or otherwise subject to the liabilities of that section. Marchex is referencing non-GAAP financial information in both the Press Release and on the conference call. A reconciliation of these non-GAAP financial measures to the comparable GAAP financial measures is contained in the attached Press Release. Disclosures regarding definitions of these financial measures used by Marchex and why Marchex s management believes these financial measures provide useful information to investors is also included in the Press Release.

#### Item 2.06 Material Impairment.

In conjunction with the preparation of its financial statements for the quarter ended June 30, 2016, Marchex recorded an estimated pre-tax \$63.3 million non-cash impairment charge based on the preliminary results of the company s goodwill tests. The goodwill impairment analysis is not final and is expected to be completed in the third quarter of 2016. We believe that the preliminary estimate of goodwill impairment is reasonable and represents our best estimate of the impairment loss to be incurred; however, it is possible that adjustments to the preliminary estimate maybe required as the calculations are finalized.

The foregoing charges when finalized will not result in any current or future cash expenditures. Marchex will provide additional information relating to this charge in its Form 10-Q for the quarterly period ended June 30, 2016.
