Under the programme Novo Nordisk will repurchase B shares for an amount of up to DKK 2 billion in the period from 31 January 2008 to 6 August 2008.

Transactions related to Novo Nordisk's incentive programmes have resulted in a net sale by Novo Nordisk of 217,620 B shares. The shares in these transactions were not part of the Safe Harbour repurchase programme. With the transactions stated above, Novo Nordisk owns a total of 28,079,960 treasury shares, corresponding to 4.3% of the share capital. The total amount of shares in the company is 646,960,000 including treasury shares.

In addition, Novo Nordisk has a leading position within areas such as haemostasis management, growth hormone therapy and hormone replacement therapy.
