Mr. Ball has been granted a total of 27,000 RSUs in three grants: (A) 15,000 RSUs granted on October 28, 2008; (B) 6,000 RSUs granted on May 6, 2009; and (C) 6,000 RSUs granted on May 4, 2010. All RSU grants vest annually in four equal installments beginning 1 year after grant date. As of this filing, 3,750 RSUs are vested.
