(1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.

(2) Represents shares transferred from CIBC Trust Co (Bahamas) Limited as Trustee of Settlement T-577. No cash consideration was paid in connection with such transfer. The transfer of shares of Class B Common Stock to the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Prior to such distribution, the Reporting Person became subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following the distribution, the shares will remain shares of Class B Common Stock.

Member of 10% owner group. Lawrence I. Richman serves as trustee of the Reporting Person and is owned by the Reporting Person. In addition, the Reporting Person may be deemed to be a member of the Reporting Person. The Reporting Person has agreed to certain voting agreements and limitations on transfers of Class A Common Stock. The Reporting Person disclaims beneficial ownership of the securities reported herein except for interest therein.
