- Each Common Voting Share is convertible into a Class A Common Share on a one-for-one basis and has no expiration date. On March 4, (1) 2013, The Edward W. Scripps Trust (the "Trust") converted 13 Common Voting Shares into 13 Class A Common Shares, resulting in the issuance of 13 Class A Common Shares to the Trust.
- Ms. Scagliotti is a Trustee of the Trust and has the power, together with the other Trustees of the Trust, to vote and dispose of the shares of the Issuer held by the Trust, subject to an order entered under seal by the Court of Common Pleas, Probate Division, Butler County, (2) Ohio on January 22, 2013, giving effect to certain of the voting provisions of the Scripps Family Agreement dated October 15, 1992, as amended. The Trust terminated on October 18, 2012 and the shares held by the Trust are expected to be distributed to the remainder beneficiaries in the next few months.
- (3) This restricted stock unit award will vest on May 2, 2013. Upon vesting, each restricted stock unit will convert into one Class A Common share of the Company.
