(1) The shares covered by this Form 4 have been sold pursuant to a Rule 10b5-1 Sales Plan dated June 30, 2014.

(2) Options for the purchase of 18,257 shares of common stock at \$40.83 per share were granted to Mr. Estes on January 21, 2008, which grant has previously been reported. The partial exercise of these options for the purchase of 11,085 shares has previously been reported. Of the remaining options, options for the purchase of 1,104 shares vested January 15, 2011 and options for the purchase of 3,034 shares vested on January 15 of each of 2012 and 2013.

(3) The options were granted under the Health Care REIT, Inc. 2005 Long-Term Incentive Plan and had no acquisition price.
