 - (1) Between July 2004 and June 2005, the reporting person acquired 54 shares of Affiliated Computer Services, Inc. Class A Common Stock, par value \$0.01 under the Affiliated Computer Services, Inc. 401k Plan (the "Plan") at purchase prices ranging from \$47.60 to \$59.88 per share.
 - (2) Between July 2004 and June 2005, the reporting person acquired 279 shares of Affiliated Computer Services, Inc. Class A Common Stock, par value \$0.01 under the Employee Stock Purchase Plan at purchase prices ranging from \$51.10 to \$60.19 per share.
 - (3) Adjusted for changes in value of units held in Plan.
 - (4) On February 2, 2005, the Board of Directors approved changes in the exercisability of options, such that these options now vest and become exercisable as follows: on each anniversary date of the grant, commencing with the first such anniversary date and continuing on each such anniversary thereafter through and including the fifth anniversary of the date of the grant, 20% of such options shall vest and become exercisable. Date of Grant is 10 years prior to stated expiration date.
 - (5) On February 2, 2005, the Board of Directors approved changes in the exercisability of options, such that these options now vest and become exercisable as follows: on the third anniversary date of the grant, 60% of such options will vest and become exercisable; and on each of the fourth and fifth anniversary dates of the grant, 20% of such options will vest and become exercisable. Date of Grant is 10 years prior to stated expiration date.
 - (6) The Exercise Price per share is \$15.65625.
