(b) Election of Director

On March 21, 2013, Era Group Inc. (the "Company") reported on a Form 8-K filed with the Securities and Exchange Commission (the "Original Form 8-K") the appointment of each of Ann Fairbanks, Christopher P. Papouras and Yueping Sun (collectively, the "Appointed Directors") to the Company's Board of Directors (the "Board") on March 18, 2013. Effective May 13, 2013, the composition of the committees of the Board is as follows: Audit Committee - Mr. Papouras (Chair), Mrs. Fairbanks and Blaine Fogg.

Compensation Committee - Mr. Fogg (Chair), Mrs. Sun and Mr. Webster.

Nominating and Corporate Governance Committee - Mr. Webster (Chair), Mrs. Fairbanks and Mrs. Sun.
