As the investment adviser to the Funds, AWM holds sole voting and investment power over 1,388,204 shares of Common Stock of the Issuer (the Shares) held by QP, 456,675 Shares held by CAYMAN and 296,857 Shares held by PE. Austin W.

Marxe (Marxe), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM.
