As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Master Fund, Ltd. beneficially own 553,783 and 246,148 shares of the Issuer's common stock (common shares), respectively, representing approximately 3.48% and 1.55% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 799,931 shares of the common shares, representing approximately 5.02% of the common shares. Sabby Management, LLC and Hal Mintz do not directly own any common shares, but each indirectly owns 799,931 common shares. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 799,931 common shares because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies. Mr. Mintz indirectly owns 799,931 common shares in his capacity as manager of Sabby Management, LLC.
