On April 23, 2018, Torchlight Energy Resources, Inc. (the "Company") issued a press release announcing that it had closed its previously announced underwritten public offering of shares of common stock at a public offering price of \$1.15 per share. The Company sold a total 5,750,000 shares under the offering, which amount includes the full exercise of the over-allotment option. The net proceeds to the Company, after deducting the underwriting discounts and commissions and estimated offering expenses payable by the Company, were approximately \$6.0 million.
