- (1) Restricted stock grant made pursuant to Issuer's 2011 Long Term Incentive Plan, exempt under Rule 16b-3.

The value of the SMCA is payable in cash following the reporting person's termination of employment with the Issuer and its subsidiaries.

- (6) Options to buy 2,675 shares become exercisable on 02/15/2019 and options to buy 2,676 shares become exercisable on each of 02/15/2020 and 02/15/2021.
