Introduction:

On March 4, 2003, Southeastern converted its Schedule 13G to a filing on Schedule 13D in order to gain the flexibility to discuss with management, other shareholders and/or additional third parties proposals to cause the Issuer's true economic value to be recognized. On July 22, 2003, the Issuer announced, among other things, that it is "concluding a strategic study designed to extract more value for its shareholders from its US timber assets." The company states that it has retained both legal and investment banking counsel to assist in the process. While waiting for the conclusion of management's study (reportedly expected by the end of the third quarter), Southeastern will cease discussions with management, other shareholders and any other parties which relate to or could result in any action or transaction described in Items (a) through (j) of Item 4 of the Schedule 13D form. Accordingly, Southeastern has elected to convert its Schedule 13D back to a Schedule 13G.
