(1) The terms of the Restricted Stock Award Agreement governing the grant to Mrs. Militello of 420 shares of restricted stock on February 15, 2011 provided that the award generally vests 100% on the one-year anniversary of the award but that upon a resignation from the board, a pro-rata portion of the award would be based upon the number of months served during that one-year period. Accordingly, upon Mrs. Militello's resignation from the board on October 31, 2011, 350 shares of restricted stock became vested and the remaining 70 shares were forfeited back to the Company.

(2) This number also reflects shares acquired under the Evans Bancorp, Inc. Dividend Reinvestment Plan as follows: 19.6959 shares on April 4, 2011 and 23.0549 shares on October 4, 2011.
