\* Pardus European Special Opportunities Master Fund L.P., a limited partnership formed under the laws of the Cayman Islands (the "Fund"), is the holder of 2,608,400 shares of the common stock, par value \$0.01 per share (the "Shares"), of Bally Total Fitness Holding Corporation, a Delaware corporation (the "Company"). Pardus Capital Management L.P., a Delaware limited partnership ("PCM"), serves as the investment manager of the Fund and possesses sole power to vote and direct the disposition of all Shares held by the Fund. Thus, as of August 30, 2005, for the purposes of Reg. Section 240.13d-3, PCM is deemed to beneficially own 2,608,400 Shares, or 7.5% of the Shares deemed issued and outstanding as of that date.

Based upon information provided by the Company, as of June 30, 2005 there were 34,645,133 Shares issued and outstanding. As of August 30, 2005, the Fund holds 2,608,400 Shares. PCM possesses sole power to vote and direct the disposition of all of the Shares held by the Fund. Thus, as of August 30, 2005, for the purposes of Reg. Section 240.13d-3, PCM may be deemed to beneficially own 2,608,400 Shares, or 7.5% of the Shares deemed issued and outstanding as of that date.
