* Pardus European Special Opportunities Master Fund L.P., a limited partnership formed under the laws of the Cayman Islands (the "Fund"), is the holder of 2,967,000 shares of the common stock, par value \$0.01 per share (the "Shares"), of Bally Total Fitness Holding Corporation, a Delaware corporation (the "Company"). Pardus Capital Management L.P., a Delaware limited partnership ("PCM"), serves as the investment manager of the Fund and possesses sole power to vote and direct the disposition of all Shares held by the Fund. Thus, as of September 1, 2005, for the purposes of Reg. Section 240.13d-3, PCM is deemed to beneficially own 2,967,000 Shares, or 8.6% of the Shares deemed issued and outstanding as of that date.

Item 5. Interest in Securities of the Issuer.

Based upon information provided by the Company, as of June 30, 2005 there were 34,645,133 Shares issued and outstanding. As of September 1, 2005, the Fund holds 2,967,000 Shares. PCM possesses sole power to vote and direct the disposition of all of the Shares held by the Fund. Thus, as of September 1, 2005, for the purposes of Reg. Section 240.13d-3, PCM may be deemed to beneficially own 2,967,000 Shares, or 8.6% of the Shares deemed issued and outstanding as of that date.

The table below sets forth the transactions in Shares, or securities convertible into, exercisable for or exchangeable for Shares, by PCM or any person or entity controlled by it or any person or entity for which it possesses voting or investment control over the securities thereof, since the filing by PCM of Amendment No. 1 to the Schedule 13D as of August 30, 2005.
