#### Item 1. Security and Issuer.

Amendment No. 19 to this Statement.

This Amendment No. 46 amends the Statement on Schedule 13D previously filed with the SEC by Mr. Sumner M. Redstone and National Amusements, Inc. ("NAI") with respect to the voting common stock, \$.50 par value per share (the "Common Shares"), of WMS Industries Inc. (the "Issuer") as follows:

#### Item 5. Interest in Securities of the Issuer.

- (a) NAI is currently the beneficial owner, with shared dispositive and no voting power of 3,483,900 Common Shares, or approximately 11.19%, of the issued and outstanding Common Shares of the Issuer (based on the number of Common Shares that were reported to be issued and outstanding as of February 4, 2005).
- (b) Mr. Sumner M. Redstone is currently the beneficial owner, with sole dispositive and no voting power, of 1,800,000 Common Shares, or approximately 5.78%, of the issued and outstanding Common Shares of the Issuer (based on the number of Common Shares that were reported by the Issuer to be issued and outstanding as of February 4, 2005). As a result of his stock ownership in NAI, Mr. Sumner M. Redstone is deemed the beneficial owner of an additional 3,483,900 Common Shares of the issued and outstanding Common Shares of the Issuer, for a total of 5,283,900 Common Shares, or approximately 16.97%, of the issued and outstanding Common Shares of the Issuer (based on the number of Common Shares that were reported by the Issuer to be issued and outstanding as of February 4, 2005).

The lack of voting power described in paragraphs (a) and (b) of this Item 5 is pursuant to the Voting Proxy Agreement, described in Item 6 of Amendment No. 19 of this Statement.

Ttem 6.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on June 6, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of June 6, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and did not make any cash payment to Buyer.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on June 13, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of June 13, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and did not make any cash payment to Buyer.

Pursuant to the terms of the Share Forward Transaction dated May 24, 2004, described in Amendment Number 35-A to Schedule 13 D, on June 24, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of June 24, 2005, Mr. Sumner Redstone delivered 333,333 of Issuer's shares and made a cash payment to Buyer based upon a settlement price of \$32.12.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on July 07, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of July 07, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and did not make any cash payment to Buyer.
