(1) Represents the sale of 12,000 shares in 58 separate transactions at prices ranging from \$35.62 to \$35.90 per share, resulting in a weighted average sale price per share of \$35.80.

(2) 07/17/00 grant of non-employee director options. The options vested and became exercisable in three installments: one-third on the date of grant, one-third on the first anniversary of the date of grant, and one-third on the second anniversary of the date of grant. The options expire on the tenth anniversary of the date of grant.

(3) 6/28/01 grant of non-employee director options. The options vested and became exercisable in four equal installments on each of (i) the date three months following the date of grant; (ii) the date six months following the date of grant; (iii) the date nine months following the date of grant and (iv) the first anniversary of the date of grant. The options expire on the tenth anniversary of the date of grant.
