Therefore, as a result of the closure of the New York Stock Exchange on October 29, 2012 and October 30, 2012 due to Hurricane Sandy, the grant date of the Reporting Person's shares is October 31, 2012. The shares were acquired in a transaction exempt under Rule 16b-3(d).
