- (3) Shares were traded to pay the tax obligation.

This option, which provided for vesting in four equal installments beginning 05/22/02, was cancelled in the merger between Beverly
- (4) Enterprises, Inc. and Pearl Senior Care, LLC (the "Merger") in exchange for a cash payment representing the difference between the exercise price of the option and the Merger consideration of \$12.50 per share for the underlying common stock.
