- (1) This transaction was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on August 3, 2011.
- On March 1, 2011, the common stock of Wisconsin Energy Corporation split 2-for-1, resulting in the reporting person's ownership of 7,379,263 additional shares of common stock indirectly held in Wisconsin Energy Corporation's Employee Retirement Savings Plan
