**EXPLANATORY NOTE**

On January 9, 2007, On Assignment, Inc. ( On Assignment ) filed a Current Report on Form 8-K to report, among other things, that on January 3, 2007, On Assignment completed its acquisition of all of the capital stock of Vista Staffing Solutions, Inc. ( Vista ) pursuant to a Stock Purchase Agreement, dated as of December 20, 2006 (the Agreement ), by and among On Assignment, VSS Holding, Inc., a Nevada corporation and parent company of Vista ( VSS ), the stockholders of VSS who own all of the issued and outstanding capital stock of VSS, and the optionholders of VSS who own all of the outstanding company stock options of VSS. In response to parts (a) and (b) of Item 9.01 of such Form 8-K, On Assignment stated that it would file by amendment the required historical VSS financial statements and the required pro forma financial information, as permitted by parts (a)(4) and (b)(2), respectively, of Item 9.01 to Form 8-K.
