**Moscow, Russian Federation** Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, affirms remarks made by its President and CEO, Leonid Melamed, that revenue for FY2007 is expected to exceed \$8 billion.

In a press interview in Minsk, Belarus, on Friday, February 29, 2008, MTS President and CEO Leonid Melamed indicated that FY2007 revenues will exceed \$8 billion. According to transcripts of the press conference, he remarked, [i]n early 2007, we forecast a 17% increase year-on-year, then adjusted it up to 22%, but we exceeded the latter, Mr. Melamed said.
