The reporting person may transfer his investment in the notional shares optional to an alternative investment account, subject to the terms of the Issuer's deferred compensation plan for non-employee directors.
- (5) Each restricted stock unit represents a contingent right to receive one share of PRU common stock.
- (6) The restricted stock units vest the earlier of the annual meeting or in one year on May 12, 2016.
