MTS Announces Decisions of its Board of Directors

April 11, 2018

**Moscow, Russian Federation PJSC MTS (NYSE: MBT, MOEX: MTSS), the leading telecommunications operator and digital service provider in Russia, announces the decisions reached at the meeting of the Board of Directors ( the Board ) held on April 10, 2018.**

At the meeting, the Board set the date for the Company's Annual General Meeting of Shareholders ( the AGM ) for June 28, 2018. The record date for the Company's shareholders and ADR-holders entitled to participate in the AGM has been set for May 25, 2018. At the meeting, the Board took the following decisions:

- The Board recommended that the AGM approve annual dividends of RUB 23.4 per ordinary MTS share (RUB 46.8 per ADR), or a total of RUB 46.76 billion (RUB 46,762,117,225.2), based on the full-year 2017 financial results.
- The Board recommended that the AGM set the record date for shareholders and ADR-holders entitled to receive dividends for the 2016 fiscal year for July 9, 2018.
