- (1) Represents the portion of previous awards of restricted stock rights that vested effective as of March 5 and 6, 2014.

The company utilizes a modified "share withholding" approach in connection with settling awards of restricted stock rights upon vesting, in which it (i) withholds (in cash) the amount required to satisfy the tax withholding obligations and remits such amount to the relevant tax authorities, and (ii) directs a designated broker to purchase on the open market the number of shares of the company's common stock that can be acquired with the after-tax value of the vested restricted stock rights award at the prevailing market price. Only these "net shares" are delivered to the recipient of the award.
- (2) The performance shares were earned as of December 31, 2013, as determined effective February 27, 2014.

Only these "net shares" are delivered to the recipient of the performance share award.
