The Trust Shares are apired with shares of Carnival Corporation common stock and are represented by the same stock certificate. The Trust Shares represent a beneficial interest in the Carnival plc special voting share.
 - Issued pursuant to Carnival Corporation 2001 Outside Director Stock Plan. The restriction on the shares lapses on the third anniversary of the grant date.
