(1) Dividend reinvestment in Ball Corporation 2000 Deferred Compensation Company Stock Plan.

Vested shares will be delivered to the reporting person in accordance with the aforementioned terms, or, if the shares are deferred, in accordance with the reporting person's deferral elections or the terms of the Plan.
