- (1) Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP). RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon the earliest of one year from the date of grant, a director's death, disability, retirement, or a change in control, as defined in the LTIP.
- (2) This total includes 1,194.41 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 12.34 units of phantom stock on 7/15/11, 12.45 units of phantom stock on 10/17/11, 12.75 units of phantom stock on 1/17/12, and 12.50 units of phantom stock on 4/16/12, pursuant to a dividend reinvestment feature of the SIP. This total also reflects the acquisition of 82.11 RSUs on 7/15/11, 82.78 RSUs on 10/17/11, 84.77 RSUs on 1/17/12, and 83.16 RSUs on 4/16/12 pursuant to a dividend reinvestment feature of the LTIP.
