On April 9, 2015 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 4,865 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in (1) two equal annual installments on the second and third anniversary of the date of grant. On April 9, 2017, 2,433 shares of the originally granted RSAs vested, of which 757 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

Between February 24, 2017 and April 11, 2017, the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan: (a) 119 shares pursuant to match contributions from the Company; and (b) 87 shares pursuant to payroll contributions. This information is based on a Plan statement dated March 31, 2017.
