(b) On October 17, 2013, FMC Technologies, Inc. (the “Company”) announced the upcoming retirement of Robert L. Potter, President, effective November 30, 2013.

John T. Grempp, age 62 and current Chairman and Chief Executive Officer, will assume the role of President, effective December 1, 2013. Mr. Grempp previously held the position of Chairman, President and Chief Executive Officer from November 2011 until August 2012. He served as the Company’s President and Chief Executive Officer from March 2011 to October 2011, and as President and Chief Operating Officer from April 2010 to February 2011. Prior to that, Mr. Grempp served as Executive Vice President of Energy Systems since 2007 and as Vice President of Energy Production Systems since 2004. Mr. Grempp has held various leadership positions within the Company, including as General Manager of Energy Production Systems, General Manager of the Fluid Control Division and General Manager of the Asia Pacific and Middle East region. He also has held various plant, operations and regional manager positions since joining the Company as a Financial Analyst in 1975.

The selection of Mr. Grempp was not pursuant to any agreement of understanding between him and any other person. There is no family relationship between Mr. Grempp and any director or executive officer of the Company. There are no transactions between Mr. Grempp and the Company that are required to be reported under Item 404(a) of Regulation S-K.

On October 17, 2013, the Company issued a news release announcing Mr. Potter’s upcoming retirement and Mr. Grempp’s appointment, a copy of which is filed herewith as Exhibit 99.1.
