Revenues for the second quarter of 2003 increased \$471,871 or 16% from \$3,002,563 in second quarter of 2002 to \$3,474,434 in second quarter of 2003. The Company attributes this growth to increased lip balm revenues.

Net Income for the second quarter of 2003 was \$61,622 or \$.01 per share compared to a loss of \$149,974 or \$.02 per share in second quarter of 2003. Gross profit increased from 24% to 28% as a percentage of sales and selling and marketing expenses decreased.
