- (1) On January 2, 2007, the Issuer entered into an agreement with Peter Herrick (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 800 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 3,400 restricted shares of Class A Common Stock issued pursuant to the Issuer's Restricted Stock Award Plan.
