Such shares vest (1) in five equal annual installments beginning on April 1, 2014, and vested shares are deliverable upon the earlier to occur of (i) April 1, 2018 or within 10 days following Mr. Poole's death or disability, provided Mr. Poole is employed by the Company on each of such dates, or (ii) following Mr. Poole's termination without cause, all as further subject to the terms and conditions of the Plan.
