- (1) On June 16, 2014, ServisFirst Bancshares, Inc. declared a 3-for-1 stock split in the form of a stock dividend. On July 16, 2014, all holders of record of common stock as of the close of business on July 9, 2014 received a distribution of an additional two shares of ServisFirst Bancshares, Inc. common stock for each share held. As a result, the reporting person received 413,104 shares of ServisFirst Bancshares, Inc. common stock as of July 16, 2014.
  - (2) The reporting person no longer has a reportable beneficial interest in shares of ServisFirst Bancshares, Inc. common stock owned by one daughter, but now has a reportable beneficial interest in shares held by another daughter.
