Borg.

According to the Company's Quarterly Report on Form 10-Q filed on November 7, 2016, as of November 4, 2016, there were 6,872,591 shares of Common Stock issued and outstanding. Accordingly, these 339,637 shares represent, to the best knowledge of Mr. Borg, as of the date of filing of this statement, approximately 4.94% of the issued and outstanding shares of Common Stock.

Mr. Borg has the sole power to vote or direct the vote and to dispose or direct the disposition of the 316,790 shares owned directly by him. Mr. Borg may be deemed to have shared power to vote or direct the vote and shared power to dispose or direct the disposition of the 22,847 shares owned by his wife. Mr. Borg disclaims beneficial ownership of the 22,847 shares currently held by his wife.
