As China Eastern Airlines Corporation Limited (the “**Company**”) completed the disposal of the entire equity interest in Eastern Air Logistics Co., Ltd.* () (“**Eastern Logistics**”) to Eastern Airlines Industry Investment Company Limited* () (“**Eastern Investment**”, a wholly-owned subsidiary of China Eastern Air Holding Company* 1. controlling shareholder of the Company) in early February 2017, the freight data and consolidated monthly data of the Company since February 2017 and subsequent months shall not include the freight data of all freighters, but only freight data of bellyhold space in passenger aircraft. The data for the corresponding period of last year shall no longer include the freight data of all freighters and shall be adjusted to comparable basis.

II. FLEET STRUCTURE

In June 2017, the Company introduced seven aircraft (one B777-300ER aircraft, two A330-300 aircraft, three A320 aircraft and one B737-800 aircraft), and retired three aircraft (two B737-700 aircraft and one B737-800 aircraft).

As the Company completed the disposal of the entire equity interest in Eastern Logistics to Eastern Investment in early February 2017, the fleet data of the Company shall no longer include the freight data operated by China Cargo Airlines Co., Limited* (), a controlled subsidiary of Eastern Logistics. As at the end of June 2017, details of the structure of aircraft of the Company are as follows:

III. BRIEF EXPLANATION ON OPERATING DATA

In relation to passenger traffic, passenger capacity (measured by available seat-kilometres) of the Company in June 2017 increased by 9.4% year-on-year, passenger traffic (measured by revenue passenger-kilometres) increased by 8.3% year-on-year, and passenger load factor decreased by 0.79 percentage points to 81.42% year-on-year. In terms of

the allocation of passenger capacity in different markets, in June 2017, based on the market predictions, the Company accordingly increased the passenger capacity of domestic routes and decreased the passenger capacity in certain markets, including Southeast Asia and Korea.

Freight transportation capacity (measured by available freight tonne-kilometres) of the Company in June 2017 increased by 11.3% year-on-year. Freight traffic volume (measured by revenue freight tonne-kilometres) increased by 6.1% year-on-year, while freight load factor decreased by 1.84 percentage points to 37.3% year-on-year.

In June 2017, the Company launched new routes such as Ningbo-Yantai-Yanji, Kunming-Urumqi, Zhengzhou-Turpan, Hefei-Manzhouli, Hangzhou-Tangshan and Foshan-Shangrao-Beijing Nanyuan.
