ATTACHMENT TO FORM 12b-25

(In this attachment, the numbers stated for first quarter 2006 are preliminary, as the financial review is not completed.)

Revenues in first quarter 2006 were \$4,518,709 compared to first quarter 2005 revenues of \$3,580,849 (a difference of \$937,860 or 26%).

Profit/Loss. In first quarter 2006 the Company had net income of \$333,895, compared to a net loss of \$15,652 in first quarter 2005 (a difference of \$349,547). The increase in net income was principally the result of the higher sales as well as improvements in gross margin.
